

GIS INTERLOCAL AGREEMENT

THIS AGREEMENT is entered into by Carbon County herein referred to as “County,” Red Lodge Rural Fire District 7, herein referred to as “District” and the City of Red Lodge herein referred to as “City”.

WHEREAS, GIS data is vital to the efficient operation of government; and

WHEREAS, the parties utilize GIS data and recognize that they have overlapping data systems that can be efficiently shared; and

WHEREAS, the parties need to move to the online storage and sharing of GIS data; and

WHEREAS, GIS Data can be most efficiently shared by utilizing a shared online account;

NOW, THEREFORE, Be It Resolved that the parties mutually agree to the following:

- I. The parties will share GIS licenses purchased and owned by the county.
- II. The County will maintain the following ESRI GIS licenses:
 - a. ArcGIS for Desktop Advanced - 1
 - b. ArcGIS Basic -2
 - c. ArcGIS online 5 user - 2
- III. Allocation:
 - a. The County will be allocated one advanced license and one basic desktop license with two (2) included online subscriptions and six (6) additional online subscriptions. (currently \$3,000 for the advanced desktop and \$300 for the basic desktop and \$4,000 for the online)
 - b. The District will be allocated one basic desktop license with one included online subscription and one additional online subscription. The District will reimburse the County cost of the licenses (currently \$400 for the basic desktop and \$500 for the online)
 - c. The City will be allocated three online subscriptions. The City will reimburse the County the cost of the licenses (currently \$1,500)
- IV. Each party shall be responsible for any proportional increases in the cost of the ESRI licenses.
- V. If usage credits or usage fees become charged to the account the parties agree to meet to discuss the allocation of the fees.
- VI. Reimbursements shall be paid to the County by the 15th of August of each year.
- VII. This agreement **does not** include the sharing of any costs for GIS personnel or for IT support (outside any free technical support provided by the vendor).
- VIII. The agreement shall be valid for five years from the date signed and shall be automatically renewed for consecutive five year periods until cancelled. Parties have the

authority to terminate this Agreement at the end of any fiscal year by giving a minimum of a 30-day notice delivered in writing to the other parties.

- IX. This agreement has been approved by the Carbon County Board of Commissioners, Red Lodge Rural Fire District 7, and the City of Red Lodge and shall be effective on the first day of July 2015.
