

Question #8: Do you have any other comments regarding the Resort Tax that you would like to share? Sixty-nine respondents commented. Several trends emerged as follows:

- 11 - would like to see resort tax money spent on marketing
- 12 - would like better communication on where the tax is spent
- 5 - are not happy with spending the tax on the police department
- 5 - thought it deterred or raised questions from tourists
- 4 - thought it did not negatively impact tourism
- 14 - had questions on infrastructure spending either questioning that it has gone to infrastructure or wants this as a priority. The desire to spend tax on parks and provide property tax relief were mentioned more than once.

Several comments at “each end of the spectrum” in favor and opposed to the tax. Representative: “Get rid of it” and “This is a vital source of revenue to support city services and a great way to spread the cost among all users, not only those who own property.”

Most innovative comment: issue tax exempt card for locals

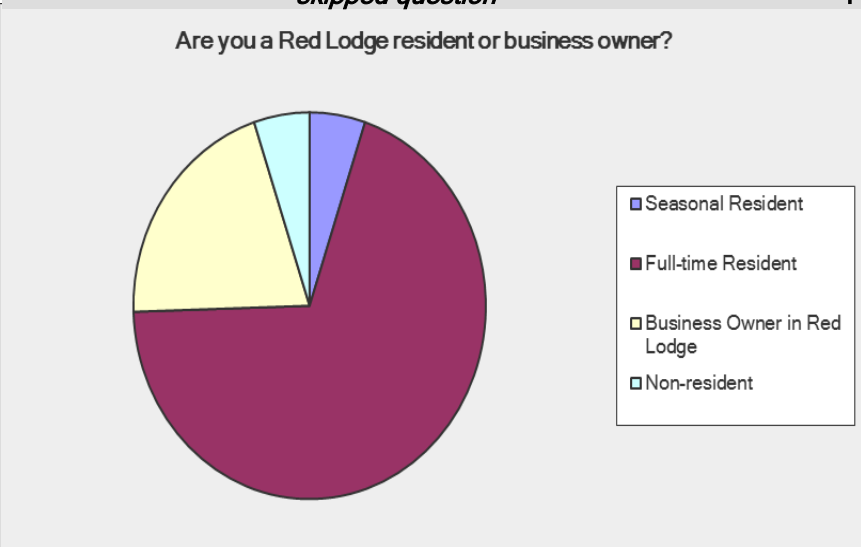

### Compilation of Online and Written Survey Comments

Bases: There were 158 people who completed the online Survey and 16 written surveys for a total of 174 respondents. Surveys were completed between March 27<sup>th</sup> (16 written surveys completed on the night of the forum) and April 15<sup>th</sup>. Questions #2, #3, #7, and #8 provided opportunity for comment by the Survey respondents. Each response was reviewed and trends identified; reported as follows:

Question #2: Does the Red Lodge Resort tax impact any of your purchasing decisions? Eleven respondents provided comments on this question. Five respondents indicated they would purchase items in Billings, four stating they do so if those items were either higher priced (than Red Lodge) or large purchases, and one simply stating they buy in Billings because of no tax.

Question # 3: If you are a Red Lodge resident or business owner, do you feel the Resort Tax provided you more benefits than costs? Thirteen respondents provided comment. They were not really able to answer the question very well from their comments. The trend of those providing comment: They would like to see definitive and more frequent are not certain they are taxing correctly.

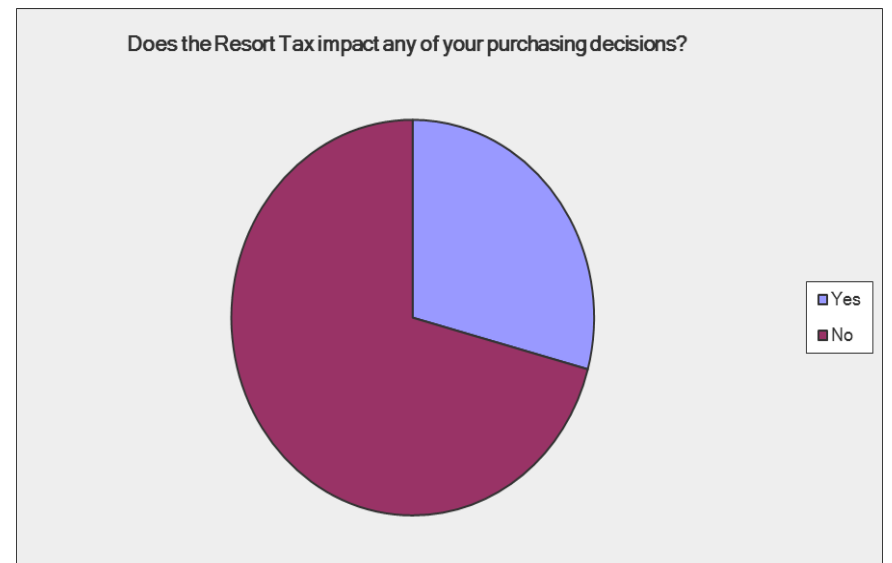

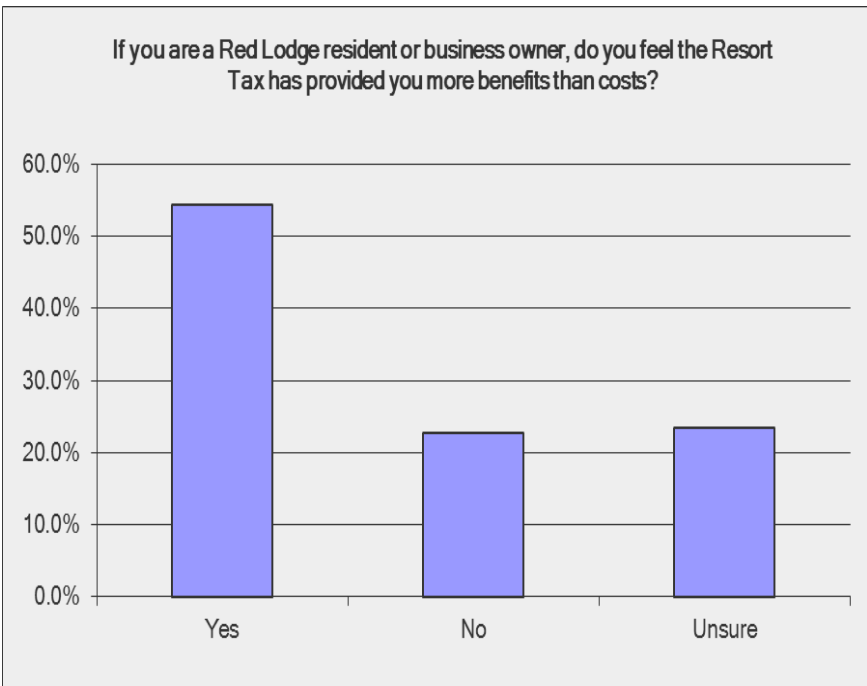

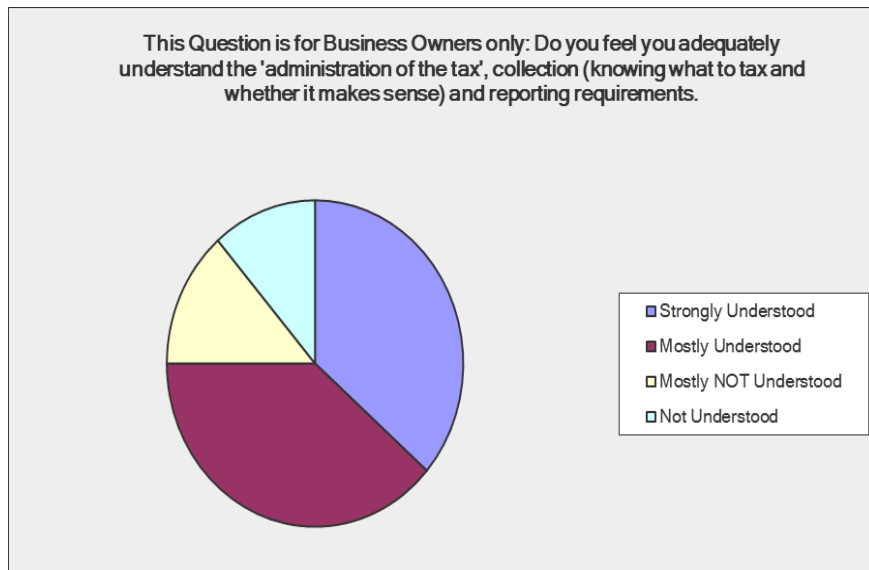

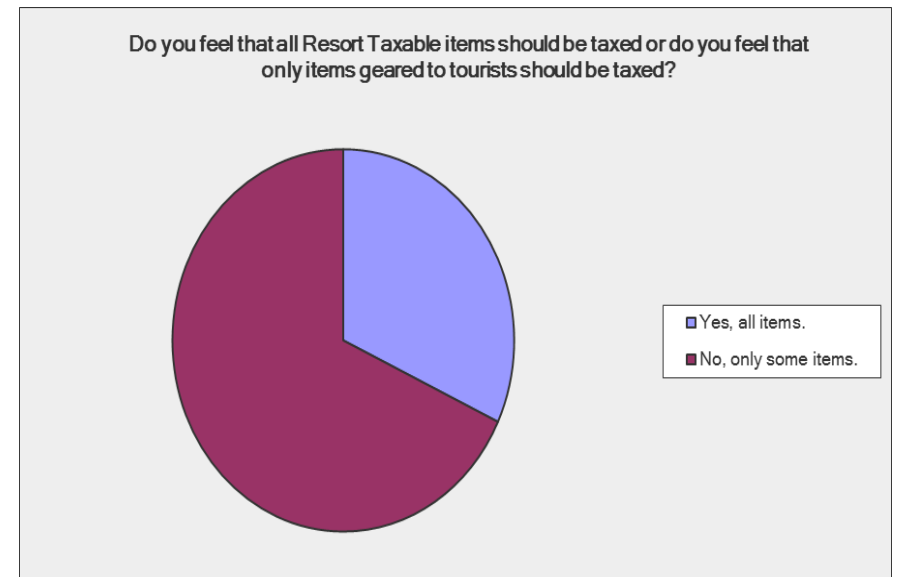

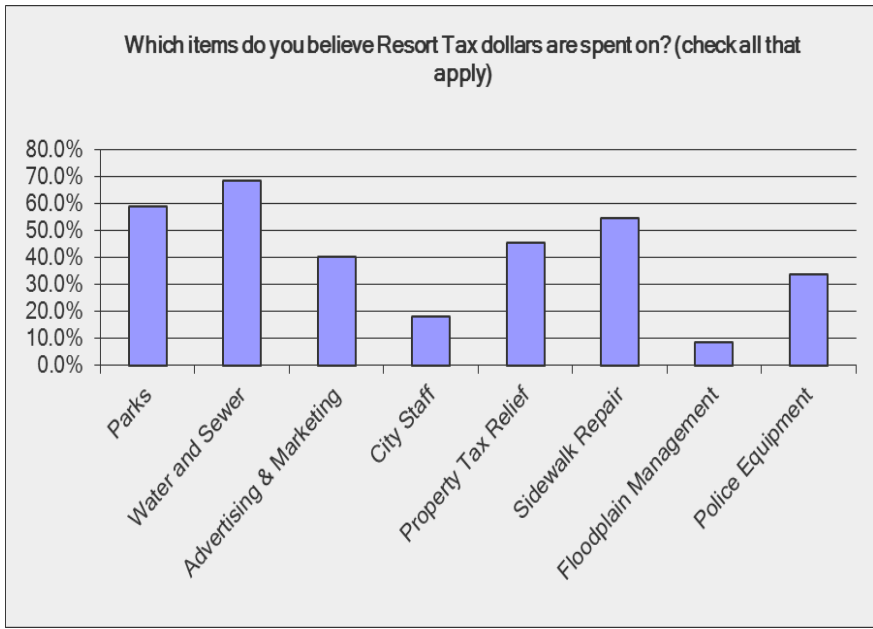
**Question #4** Do you feel that all Resort Taxable items should be taxed or do you feel that only items geared to tourists should be taxed?
